PURPOSE & PHILOSOPHY

MANUAL & FACILITY

WHO CAN ATTEND?

The school is open to graduates of IBA's Compliance School, either lending module, deposit module, or both. Graduates of the 2024 Lending Compliance and Deposit/Operations Compliance schools are eligible to attend. Confirmation is e-mailed to registrants prior to the school.

TUITION

Tuition includes program instruction, comprehensive curriculum materials, continental breakfast, coffee breaks and lunch. Payment of tuition is required at the time of application. Any application withdrawing 30 days or more prior to the school will receive a full refund. If the applicant withdraws fewer than 30 days before the school begins, a \$50 non-refundable deposit will be retained.
